## **Key Findings**

Idaho voters overwhelmingly support education freedom and giving families more flexibility to tailor an education for each child. They strongly approve of Idaho's Parental Choice Tax Credit and will punish lawmakers who try to abolish it.

### **Overwhelming Support for Education Freedom**

Voters across Idaho support giving parents the flexibility to choose the best school for their children.

- 82% support education freedom, including more than six-in-ten (61%) who strongly support it.
- 69% support giving families more choices in how they can educate their children, from the schools they can attend to the financial resources to help cover expenses.

### Strong Approval of Idaho Parental Choice Tax Credit

Voters approve of the state's refundable tax credit program.

- 64% approve of the new program lawmakers and Gov. Little established earlier this year.
- 77% of K-12 parents are personally interested in participating in this program with their children; 56% are *very* interested.
- Voters support the program because it gives families more control to personalize education.
  - Gives families more of a say in their kids' educations. (71% said this benefit was most convincing reason to support the program)
  - Lets families better tailor an education for each of their kids. (66%)

#### **Opposition to Lawmakers Abolishing Tax Credit Program**

Voters will punish lawmakers who try to abolish the program.

• 45% – nearly half of voters statewide – would be less likely to vote for their legislator if their legislator wanted to get rid of the program.

### Methodology

yes. every kid. foundation. conducted a multi-modal survey of n=604 registered voters in Idaho from September 22-24, 2025. The survey was stratified based on the known demographic composition of the Idaho registered voter population. Results for the entire population have a margin of error of  $\pm 1.0\%$ .
