Key Findings

- ✓ **Mississippians support school choice and letting parents make decisions.** Seven-in-ten Mississippi voters support school choice, including 40% who *strongly* support it. Only 17% of voters oppose. Support is being driven by likely Republican primary voters (79%).
 - Support jumps by double-digits to 81% with *strongly* support jumping to 55% when Mississippian's are informed that school choice allows parents, instead of the government, to choose the best school for their child. Fully, 90% of likely Republican primary voters support letting parents choose the best school for their child.
- ✓ By a 3:1 margin, voters support mandatory district participation in a statewide open enrollment program. Roughly three-quarters (73%) of voters and 78% of likely Republican primary voters support the legislature passing a law allowing all children in Mississippi to access any public school in the state. A significant 43% and 47% of each audience, respectively, strongly support this.
 - Moreover, near equal amounts of both audiences 68% of voters and 72% of likely Republican primary voters support making it mandatory for all districts to participate in a statewide program. A majority of voters (55%) and likely Republican primary voters (59%) would be more likely to vote for a lawmaker who supported mandatory participation, while only 21% and 20% of each audience, respectively, would be less likely.
- ✓ Statewide demand for expanding the state's ESA program to all families. Not only do 66% of Mississippi voters and 76% of likely Republican primary voters support Education Savings Accounts, but both audiences believe they should be expanded to all families across the state:
 - 72% of voters and 84% of likely Republican primary voters believe they should be available to all families across the state rather than limited to low-income families.
 - 74% of voters and 80% of likely Republican primary voters believe they should be available
 to all families across the state rather than limited to families in D or F rated districts.
- ✓ **Voters strongly support a refundable income tax credit.** Sixty-seven percent of voters in the state, as well as 75% of likely Republican primary voters, support enacting a refundable income tax credit in Mississippi, 48 and 61 percentage points, respectively, higher than those who oppose.
