Key Findings

- ✓ Most homeschool families in the United States began homeschooling following the outbreak of COVID-19. Eighty-seven percent of homeschool parents started homeschooling their children at the start of the 2021 school year or after. In fact, 58% of homeschool families are brand new to homeschooling, having started in the past two school years.
- ✓ **Homeschool families today are as diverse as America.** As the homeschool community continues to expand, it becomes more representative of America, sharing a similar composition to the overall U.S. population on key demographics like geography and race/ethnicity.
- ✓ Homeschool parents do not believe their state leaders spend enough time focusing on k-12 education. Two-thirds of homeschool parents believe their elected leaders spend too little time focused on k-12 education, while only 5% believe they spend too much time; 22% believe they spend the right amount of time. Republicans, moms, non-white parents, households with incomes under \$100,000, and both suburban and rural parents most believe state leaders spend too little time.
- ✓ A majority of homeschool parents believe the current homeschool regulations in their states are about right. Six-in-ten parents say current regulations in their respective states are about right, while the remaining parents are split − 16% say too tight, while 18% say too loose. Families new to homeschooling within the past two school years (58% of all homeschool families) are most receptive to new regulations − 55% about right, 15% too tight, 22% too loose, while families who began homeschooling before the COVID-19 pandemic (13% of all homeschool families) are least receptive to new regulations − 68% about right, 22% too tight, 5% too loose.
- ✓ **Homeschool parents seek more options.** Eighty-three percent of homeschool parents believe it is *very* important to give parents more options to improve their children's education. Families who started homeschooling before the COVID-19 pandemic (13% of all homeschool families) are most sympathetic to more options (91% believe it's *very* important).
- ✓ Nine-in-ten homeschool parents agree that homeschool and private school children should be able to attend a public school on a course-by-course basis. Further, 80% believe providing these children access to public schools would improve their state's k-12 education system.
- ✓ By significant margins, homeschool parents support Education Savings Accounts and tax-credit programs. Eighty-four percent of parents support ESAs, while 88% of parents support tax-credit programs. In fact, a majority of parents strongly support each policy: 53% strongly support ESAs, 58% strongly support tax credits. Support for each policy is equally strong among families who began homeschooling before the COVID-19 pandemic and after.
- ✓ Two-thirds of homeschool parents fundamentally believe the decision to accept state funding for education should be left to families, but for this to happen, programs like ESAs need to be established in the first place. Only 27% of homeschool parents believe these programs are a way for government to monitor people and should not be established in the first place. At least three-fifths of every demographic subgroup supports establishing these programs.
